MCHENRY COUNTY MENTAL HEALTH BOARD

In compliance with the Illinois Statute governing the Community Mental Health Act (Illinois Compiled Statutes, Chapter 405, Act 20), the McHenry County Mental Health Board (MCMHB) provides this annual report to the community to outline major activities and accomplishments, sources of revenues, and expenditures for the year ending November 30, 2019.

In carrying out the statutory mandates of the Community Mental Health Act, the MCMHB stands accountable to the community and embraces its role as a responsible and trusted steward of local taxpayer dollars. The MCMHB is committed to ensuring levied funds are allocated in a responsible manner to address mental illness, substance use, and intellectual and developmental disability needs for all residents of McHenry County. Allocated funds support network activities such as training, marketing, and special projects as well as over 80 services and programs administered by 34 service providers.

When applying national prevalence rates upon the population of McHenry County, it can be safely assumed that almost a third of our families, friends, co-workers, and neighbors are impacted by mental illness, substance use disorder, or intellectual and developmental disabilities at any given time. This universal and extensive prevalence is often referenced as "the" public health challenge of our time, and yet, stigma and silos still exist.

Therefore, on behalf of its constituency, the MCMHB promotes strong relationships with individuals in recovery, their families, healthcare providers, local county systems such as education, criminal justice, law enforcement, health and human services, businesses, faith-based organizations, and community members alike to foster a recovery ready community.

Together, we have accomplished a lot this year. Our efforts resulted in the reduction of local lives lost to overdose and suicide, but the work is ongoing. Moving ahead, we look forward to sustaining current efforts while supporting new developments such as a Year-Round Homeless Shelter and a 30-bed Recovery Residence, both of which add strength to the infrastructure of recovery.

Please stay informed, engaged, and active as we all play a role in empowering minds and transforming lives. The MCMHB invites you in joining us in reflecting on some of this past year's highlights and accomplishments.



The MCMHB is a special purpose unit of government operating in accordance with the **Community Mental Health Act** (Illinois Compiled Statutes, Chapter 405, Act 20, Section 0.1 et. seq.). Through the direction of a board of community representatives appointed by the County Board and a dedicated MCMHB staff, the MCMHB is mandated to carry out the following activities:



- Submit to the appointing officer and the members of the governing body a
 written plan for a program of community mental health services and facilities
 for persons with a mental illness, a developmental disability, or a substance use
 disorder.
- Within amounts appropriated therefore, execute such programs and maintain such services and facilities as may be authorized under such appropriations.
- Review and evaluate community mental health services and facilities, including services and facilities for the treatment of alcoholism, drug addiction, developmental disabilities, and intellectual disabilities.

FY19 MCMHB HIGHLIGHTS

MCHENRY COUNTY MENTAL HEALTH BOARD

The MCMHB holds a 3-year CARF International Behavioral Health Network accreditation demonstrating conformance to internationally accepted standards promoting quality outcomes for persons served. Network activities are carried out through 34 contracted network service providers and MCMHB facilitated Network Council, Intake Coordinators, Quality Management Team, and Clinical Review meetings, as well as continuous contract compliance audits.



- In December of 2018, the MCMHB received the Community Behavioral Health Association's Ellen T. Quinn Memorial Award. The MCMHB attributes the honor and recognition to the collective vision and efforts of the Board of Directors, staff, and network partners.
- The MCMHB Board President, Connee Meschini, was recognized by the Northwest Herald as a "Woman of Distinction" for her leadership and years of public service on the Mental Health Board.
- MCMHB satisfied all Series 2010-B debt certificates from the annex facility addition.
- Leased office space to seven local not-for-profit organizations.
- Went "live" with use of the D365 Enterprise Resource Planning System.
- Maintained intergovernmental agreements with the County of McHenry for IT and routine maintenance services.

The MCMHB is a proud member of the Health Care Compliance Association and shares lessons learned with a Quality Management Team (QMT) made up of MCMHB Network Providers.



The QMT reviews MCMHB network outcomes and promotes sharing and understanding of industry related compliance trends, contractual obligations, and organizational integrity through the operation of effective compliance programs and activities. Over the course of FY19, QMT reviewed:

QPR Suicide Prevention Trainings

These 3 simple steps may help save a life!

QPR (Question, Persuade, Refer) is an evidence-based practice that focuses on how to recognize persons who may be at risk of suicide, persuade them to seek and accept help, and refer them to appropriate resources.

Mental Health First Aid

15 trainings reaching 214 attendees

Attendees learn risk factors and warning signs for mental health and addiction concerns, strategies for how to help someone in both crisis and non-crisis situations, and where to turn for help.

Youth Mental Health First Aid

30 facilitators trained

Facilitators are certified to teach parents, family members, caregivers, teachers, school staff, peers, human services workers, etc. how to help an adolescent (age 12-18) who is experiencing a mental health or addictions challenge.



The MCMHB has adopted a revised version of the SAMHSA National Outcome Measures (NOMs) Framework to promote the use of consistent measures across its network. Over 30 evidence-based practices and various validated tools are utilized.

MCMHB FUNDING TYPES

Fee-for-Service

Payments for each event of service. When possible, rates are based on those set by the State of Illinois.

Standard Grant

Provides funds for access to specific care or the infrastructure of a program and requires year-end reconciliation of actual expenses.


Purchase of Position

Payment for a particular staff position critical to the delivery of an approved service or program for which Fee-for-Service funding is not applicable.


Pay-for-Performance Grant

FUNDING BY NEED






FY 2019 Revenue

- (1) McHenry County Audits for 2019 will not be finalized until at least the end of May 2020. As a result, at the time of printing, this financial summary is based on unaudited numbers.
- (2) Administrative expenses are higher than normal due to early repayment of Series 2010B Debt Service in 2019. There will be a savings of over \$200,000 in interest expense as a result of the early repayment.
